#### FROM THE SUPERVISOR

The Town completed its fiscal year on Dec. 31. In 2012 the Town adopted a budget with an increase in the tax levy of 1.7% (below the tax cap of 2%). A new printer/copier was purchased for the Justice Court with funds from a NYS Justice Court Assistance Program grant. The Town also received its first county sales tax check in three years. The Planning Board is working with the Town Board on a road use agreement, a road protection law and a moratorium, all related to hydrofracking. The Town has renewed its agreements for dog holding services with Stray Haven and also for code enforcement services with the Town of Caroline. The Town Board still holds its monthly meetings on the second Tuesday at 7 p.m.

# **TOWN BOARD NEWS**

#### **September 11,2012**

The regular Town of Richford Board meeting was called to order at 7:20 p.m. by Supervisor Wilcox. All Board members were present. Six townspeople were also in attendance. The Berkshire Emergency Squad was present and asked that the Town of Richford send a liaison to the monthly meetings of the Squad to report back to the Town Board. The Town Clerk's and Supervisor's reports for August 2012 were presented. The Highway Superintendent was not present, but did report to Supervisor Wilcox that they plan to stone and oil roads beginning Thursday or Monday. Supervisor Wilcox was asked to inquire of Mr. Holt regarding a product used on roads in place of salt brine and has a hard finish to it. A Town Planning Board report was given. They are preparing a draft of a "Road Use Agreement" as requested by the Town Board. There was a short discussion on the number of members on the Planning Board. The Town Board also instructed the Planning Board to to work on a new draft of a One Year Moratorium Law on gas drilling after the Road Use Agreement and Road Preservation Law are completed. A resolution concerning the lowering of speed limits on certain town roads within the Town of Richford was adopted and will be forwarded to the State of NY for review. There was discussion regarding the 2013 Town Budget. Supervisor Wilcox presented a draft of a local law to override the NYS tax cap. A Public Hearing on the proposed tax override local law on October 9, 2012 at 6:30 pm. The meeting was adjourned at 8:45 p.m.

#### October 9, 2012 Public Hearing:

Supervisor Wilcox called the Public Hearing regarding proposed Local Law #2 of 2012, a Local Law to Override the Tax Levy Limit Established in General Municipal Law 3-C at 6:37 pm. Twenty-eight townspeople were also in attendance and ask questions and/or made statements for or against proposed Local Law #2 of 2012. After much discussion and after asking for any further comments, Supervisor Wilcox closed the Public Hearing at 7:15 pm.

# October 9, 2012 Board Meeting:

The regular Town of Richford Board meeting was called to order at 7:17 p.m. by Supervisor Wilcox. Twenty townspeople were also in attendance. A representative of the Berkshire Emergency Squad was present and talked regarding their budget. Minutes of the September 11, 2012 regular monthly Town Board Meeting were presented and approved. The Town Clerk's and Supervisor's reports for September 2012 were presented. The Highway Superintendent gave a report. Perry Road has been worked on and plans for the Highway Garage septic and changing a dump truck to a sander truck are also being worked on. A Code Enforcement and Justice Court report for September 2012 was presented. There was no dog control report for September 2012. A Town Planning Board report was given. They have been working on a draft of a road preservation law. The Town Board approved a tire collection day on September 22, 2012 from 8:00 am to 2:00 pm at the garbage truck location. The fees will remain the same as they were in the spring. The Board agreed to update the current employee payroll program. The meeting was adjourned at 8:45 p.m.

# **November 8, 2012 Public Hearing:**

Supervisor Wilcox called the Public Hearing on the Town of Richford 2012 Preliminary Budget to order at 6:42 pm. Councilman Miller and Councilwoman Herrick were present. Councilman Mead and Councilwoman Brown were absent. Three townspeople were also in attendance. There was discussion regarding several questions pertaining to the 2013 Preliminary Budget. Supervisor Wilcox closed the Public Hearing at 7: 18 pm.

#### November 13, 2012 Board Meeting:

The regular Town of Richford Board meeting was called to order at 7:20 p.m. by Supervisor Wilcox. The minutes of the October 9, 2012 and November 8, 2012 Public Hearings, the October 9, 2012 regular monthly Town Board Meeting and the Special Town Board meeting held on October 16, 2012 were presented and approved. The Town Clerk's and Supervisor's reports for October 2012 were presented. Superintendent report for October 2012 was presented. The new septic system at the Highway Garage has been completed and the CHIPS paperwork has been completed and mailed. A new radio was purchased for one of the trucks. A Town Planning Board report was given. There was discussion regarding the 2013 Town of Richford Preliminary Budget. Changes where made and the Preliminary Budget was approved. A motion to appropriate \$35,000.00 toward the purchase of a new pick-up truck was approved. A resolution to adopt the Town of Richford 2013 Preliminary Budget was approved. The meeting was adjourned at 9:03 p.m.

#### December 11, 2012 Board Meeting:

The regular Town of Richford Board meeting was called to order at 7:25 p.m. by Supervisor Wilcox. Two townspeople were in attendance. The minutes of the November 13, 2012 regular monthly Town Board Meeting were presented and approved. The Town Clerk's and Supervisor's reports for November 2012 were presented. The Highway Superintendents report for November 2012 was presented. Winter sand has been hauled in and all trucks have been repaired and are ready to be used. The Barden Road Bridge project has been completed. Code Enforcement, Dog Control and Justice Court reports for November 2012 were presented. A Town Planning Board report was given The Planning Board would like to have a Road Use and Road Preservation Laws draft ready by years end. A motion to hold a year-end meeting at 7:00 pm on Thursday, December 27, 2012 was approved. The meeting was adjourned at 9:17 p.m.

# December 27, 2012 Special Board Meeting:

Supervisor Wilcox called the special year-end meeting to order at 7:30 p.m. Councilwoman Herrick and Councilman Miller were present. Councilwoman Brown and Councilman Mead were absent. Four townspeople were also in attendance. Board members finalized 2012 business. The meeting adjourn at 8:40 p.m.

# REMINDERS FROM THE ASSESSOR

Town Assessor Frances Butler reminds residents that applications for all property exemptions must be received in her office by March 1, 2013. If you own property that is your main residence, you are eligible for the STAR (School Tax Relief) exemption. The basic STAR is for all property owners (apply one time only) and the enhanced STAR is for seniors who meet certain income and age requirements. Seniors must apply for the enhanced STAR each year.

Other exemptions are available for senior citizens, agriculture, and veterans. Seniors, age 65 and over, with a yearly income of \$23,999 or under are eligible for a sliding scale for aged exemption of Town property taxes. Renewal forms have been sent to residents who applied last year for the enhanced STAR and or the sliding scale property exemption. Low income seniors are also reminded that the Newark Valley School District and Tioga County have different income levels for residents to apply for property tax exemptions. Tioga County has a yearly income of \$24,300. Please check with the Assessor if you or a family member may be eligible for one or more exemptions. #### BERKSHIRE EMS

The Town of Richford currently has a contract with the Berkshire Emergency Squad for ambulance service for residents. The 911 emergency call goes to the Tioga County dispatcher, who in turn, calls the Berkshire Emergency Squad. If the Squad is unavailable, then another squad is called through mutual aid by the dispatcher. The contract which the Town of Richford has with the Squad calls for a 20 percent deductible on the bill. The ambulance bill can vary depending on the medical needs of the patient being transported. If you cannot pay the bill, please call the Berkshire EMS at 642-3451. #### TROUT HABITAT PROTECTED

The Finger Lakes Land Trust announced that it has accepted the donation of a conservation easement from landowner Jeanne Paisley on her 120-acre property bordering the East Branch of Owego Creek. Conservation easements are legal agreements that limit future development while allowing land to remain in private ownership and on the tax rolls. In this case, the easement provides for vegetated buffers along the creek while allowing for continued use of the land for agriculture and forestry.
